Wisconsin DPI	Nita M. Lowey 21st Century Community Learning Center Program	4,725,000	Grant funds will be used to provide students with academic support, enrichment, and youth development opportunities in an after-school setting at Community Learning Centers.
Department of Health and Human Services	Love 146- Not a Number Child Trafficking and Exploitation Pr	450,000	Funds will be used to train district staff (ie. school social workers, psychologists, nurses, and possibly counselors) to deliver 5-module interactive prevention curriculum entitled "Not a Number," to teach middle and high school students in schools throughout the district how to protect themselves from human trafficking and exploitation. There would be cohorts of 20 staff with up to 3 cohorts per year being trained to deliver this curriculum. The grant will provide all materials needed, trainings, and dedicated staffing time to oversee the requirements of the grant.

Office of Head Start	Office of Head Start - COLA and QI	1,071,849	The Cost of Living Adjustment supports a 5.60 percent adjustment above FY 2022 funding levels to increase the pay scales of Head Start staff, including vacant positions, fringe benefits, and to offset higher operating costs. Quality Improvement funds are allocated proportionately based on federal funded enrollment levels.
