

**(ATTACHMENT 3) ACTION ON REQUEST TO WAIVE ADMINISTRATIVE POLICY  
3.09(9)(e) AND EXTEND CONTRACTS FOR TRANSPORTATION SERVICES**

**MILWAUKEE BOARD OF SCHOOL DIRECTORS  
BUSING CONTRACT EXTENSION & MODIFICATION**

On July 1, 2014, the Milwaukee Board of School Directors ("MPS" or "Board") and Dairyland Buses, Inc. ("Contractor") entered into Busing Contract number C021112 (the "Contract") with a term of July 1, 2014, through June 30, 2015. The Contract, (¶ 2), provided for two additional one-year extensions subject to Board approval and contingent on the appropriation of Board funds. The parties mutually agree to extend the Contract for the first additional one-year period.

As such, the Contract will be extended for a term from July 1, 2015 through June 30, 2016 under the same terms and conditions as set forth in the original Contract, except for those specifically modified below.

The amount to be encumbered in this additional one-year extension period shall not exceed \$7,061,610.00.

In accordance with ¶ 19 of the Contract, the parties modify those terms and conditions identified below.


**MODIFIED TERMS:**

1. Paragraph 1 of the Contract is modified to provide that Contractor agrees to perform the services in accordance with MPS's "General Specifications and Operating Procedures, 2015 – 2016 School Year", which are incorporated into the Contract by reference. This document replaces and supplants the 2014 – 2015 Specifications and Procedures. Any other references to the 2014 – 2015 Specifications and Procedures in the Contract are similarly replaced and supplanted.
2. Paragraph 3 of the Contract is modified as follows:
  - a. the table found therein is replaced with the table below.

Type	Base Amount	Cost Per Hour	Cost Per Mile
16-35 passenger	\$158.78	\$22.56	\$0.38
36-72 passenger	\$180.36	\$22.42	\$0.55

- b. the amount to be encumbered for this additional one-year extension period shall not exceed \$7,061,610.00; the initial payment which may be made ten days before services begin will be \$706,161.00.
3. Paragraph 16(C) of the Contract is modified as follows: the existing text is replaced with "MPS has a Livable Wage policy that requires anyone having a contract with MPS to pay all of their employees a livable wage in accordance with City of Milwaukee Ordinance 310-13. The current livable wage rate can be found at the City of Milwaukee website <http://city.milwaukee.gov/ImageLibrary/Groups/daoPurchasing/forms/livingWageTable.docx>."
