On May 29<sup>th</sup>, 2020, the Milwaukee Board of School Directors and Cooperative Educational Service Agency #1 ("Contract" or "CESA #1"), entered into Professional Services Contract number C029524 with a term of July 1, 2020 through June 30, 2021. The Contract was modified via a modification (the "First Modification") to include the Elementary and Secondary School Emergency Relief (ESSER) funding. The Contract was modified via a modification (the "Second Modification") to include the Governor's Emergency Education Relief (GEER) funding. The Contract was modified via a modification (the "First Extension & Modification") to extend the Contract for a second term, from July 1, 2021 through June 30, 2022 ("Year 2") and to add additional funds.
